CIRCULAR

Subject : Restructuring of Examination Pattern and Promotion Policy for classes I-VIII, XI w.e.f. academic session 2010-11

The Right of Children to Free and Compulsory Education Act 2009 (RTEA-2009) has come into force w.e.f. 1st April, 2010. As per the provisions of section 16 of the Act, no child admitted in a school shall be held back in any class or expelled from school till the completion of elementary education i.e. upto class VIII.

Further, Central Board of Secondary Education introduced Continuous and Comprehensive Evaluation (CCE) in classes IX-X w.e.f. academic session 2009-10 for all school affiliated to CBSE. For the purpose of CCE, an academic year has been divided into two terms, April-September as First Term and October-March as Second Term. All Govt./Govt. Aided schools affiliated to CBSE have been following these changes in classes IX-X.

In the light of above developments in the education system, it becomes necessary to review our existing system for classes I-VIII and IX-XII also so as to bring uniformity in evaluation/assessment patterns.

Accordingly, w.e.f. the academic session 2010-11 the old system of having three terms in an academic session is done away with two terms. The New Examination Pattern and Promotion Policy for classes I-VIII, XI which is based on Continuous and Comprehensive Evaluation (CCE) system of the CBSE and is also approved by the Administrator of Delhi under Rule 41 of Delhi School Education Act and Rules 1973 is enclosed herewith.

All the Heads of Government and Government Aided schools in the National Capital Territory of Delhi are hereby directed to follow the enclosed instructions.

Heads of Recognized Unaided schools are also advised to follow the same.
